## 2 – Guide

- You: the natural person or legal entity with whom we conclude or wish to conclude an agreement, other party to these general terms and conditions;
- Written: communication by post, e-mail or app (a WhatsApp message for example);

### 3 – Applicability of these conditions

Our general terms and conditions apply to every agreement you enter into with us, subscriptions (and renewals thereof), to our offers, events, and to all other activities we perform for you.

Do you have your own general terms and conditions? Be aware that your general terms and conditions are not applicable and are expressly rejected by us. Therefore, we will work together under our conditions.

### 4 – Amendment of these conditions

These general terms and conditions may be amended from time to time. In case of a significant change, we will announce the changes or additions at least 14 days before they come into effect via email. The amended terms will also be posted on the website.

### 5 – Offer and conclusion of the agreement

The offer is non-binding unless we have specified an acceptance period in the offer.

The agreement is concluded either after placing an order, or after you have otherwise agreed to our offer.

We always have the right to refuse an application for our event or membership. Any amounts already paid will be refunded.



Is there a clear error ('a manifest mistake or typographical error') in our offer? Then, we are not bound by this mistake.

You must provide all information that we reasonably need to prepare a quote or make a suitable offer. We reserve the right to adjust the specified fee and deadlines if it turns out that the quote and/or offer is based on incorrect or incomplete information.

## 6 – Execution of the agreement

We have the right to change or terminate our agreement at any time without the need for notice.

If you bring a visitor, you ensure that this visitor adheres to Easy2Network' general terms and conditions. You are responsible for (the behavior of) the visitor.

Easy2Network may be closed during holidays and public holidays.

We may involve third parties in the execution of the agreement.

We undertake an obligation of best efforts for the execution of the agreement, unless we have explicitly promised a result and this result is sufficiently defined.

It is not allowed to transfer the rights and obligations arising from the agreement to a third party unless we have given our consent or unless something else is stipulated in these general terms and conditions.



## 7 – Events

We expect you to actively participate so that you can get the most out of our events.

We are not responsible for achieving a specific result.

For the events, payments are upfront.

**Non-Refundable Tickets:** Cancellations are accepted up to 1 week in advance. After this period, no refunds will be given.

We may change and/or supplement the content of an event at any time. A change or addition does not entitle you to a refund or compensation unless it is a very significant change.

**Ticket Transfer:** If you are unable to attend an event after purchasing a ticket, you may transfer your ticket to another participant with our consent. To request a ticket transfer, please contact us at [connect@easy2network.com](mailto:connect@easy2network.com) with the details of the new attendee.

**Approval Required:** We reserve the right to approve or deny any ticket transfer requests. Our events are small in size and tailored to specific subjects, therefore, any substitute participant must meet our criteria and be approved by us prior to the event.

**Transfer Process:** Upon receiving a request for ticket transfer, we will review the proposed substitute participant and notify you of our decision within a reasonable



time frame. If approved, the ticket will be transferred to the new attendee, and they will be provided with all relevant event details.

**Responsibility:** Please note that the original ticket holder remains responsible for ensuring that the substitute participant adheres to all event rules and regulations.

By purchasing a ticket to our events, you agree to abide by these terms and conditions. If you have any questions or concerns, please contact us for clarification.

## 8 – Intellectual property

The intellectual property (copyright, design right, trademark right, etc.) in the designs, texts, workbooks, videos, course materials, and other creations used and developed by Easy2Network belongs to Easy2Network or its licensors. You may only use these materials for personal (and therefore non-commercial) purposes. Without our prior consent, such material may not be made public, reproduced, or otherwise made available to third parties.

## 9 - Privacy

It is not allowed to record, share, or distribute ideas and/or information shared by members without permission, and/or to record images without permission.

## 13 – Price and payment

We have the right to change the rates of Easy2Network. We will communicate this in a timely manner via email. If you are a member at Easy2Network and do not agree to



a price change, you are free to terminate the membership as of the date the changed prices apply.

Payments of events are processed through the Eventbrite. This means that we share necessary (personal) data, such as payment details, with Eventbrite. You understand and accept this. For invoices, we will send you a reminder once to pay within 7 days. After this period you are automatically in default after the expiration of the additional payment term. Moreover, all extrajudicial and judicial (collection) costs (such as costs for bailiffs, lawyers, collection agencies, etc.) will be at your expense.

Objections to an invoice do not suspend your payment obligation.

Payment must be made without deduction, suspension, or setoff.

#### 14 – Liability

Our liability for any damage suffered by you, a visitor, participant, guest, or other third party, as a result of an unlawful act, an attributable failure in the performance of the agreement, force majeure, or otherwise, is excluded (unless otherwise determined in these conditions). Indirect damage (such as reputational damage, consequential damage, loss of profit, or savings) is never for our account. Damage caused by (engaged) third parties is also not for our account. If we are liable, the maximum amount payable is limited to the amount paid out by Easy2Network's insurance, plus the deductible. If the insurer, for any reason, does not pay, the maximum amount payable is limited to the (last) invoice amount, with a maximum of 1,000 euros (including VAT).
